2006-2027 TE Set Rate

The Tuition Exchange Board of Directors have announced that the 2026-2027 TE Set Rate amount for schools that opt not to offer full tuition TE scholarships will be **\$44,000**. Schools, of course, may offer an amount more than full tuition or a scholarship amount somewhere between the TE Set Rate amount and full tuition.

Participation Fee Invoices

TE member schools will receive Participation Fee invoices via email on October 16th. As a reminder, the \$55 annual participation fee is paid by the Export school for any Exports that are Enrolled by their Import school for 2025-2026. Please review your PFee invoices carefully. If you notice a duplicate Export student on your invoice, it is likely you accidentally *Export Approved* the same student

To rectify this issue, please close out the duplicate application by updating the Export status to *Denied-Other* or *No Longer Eligible* and email klev@tuitionexchange.org so your PFee invoice can be adjusted. In these instances, it's always a good idea to also notify the Import TELO so they are aware that you are simply closing out the duplicate application and the student remains an eligible Export of your institution.

Don't forget - there is no convenience fee for paying any TE invoices by credit card. To enable another individual at your school to pay via credit card in the TELO system, please add that individual as a Billing User. Be sure to email Kristine Lev, klev@tuitionexchange.org if you DO add a new Billing User so she can waive their training requirement flag to give them system access.

TELO Tip of the Month

Did You Know...

If one of your Export students applied for TE (or FACHEX) for the 2025-2026 year but did not receive it, and is now interested in re-applying for consideration for the 2026-2027 year, you must close out the 2025-2026 Export application (update the Export status to *Denied-Other* and let the student know they can now submit their 2026-2027 TE EZ-Application). Until you complete this step, they will not be able to do so.

When schools completed their fall 2025 TE enrollment review, they were required to confirm completion bv clickina confirmation box on the Enrollment Report. In case you completed vour fall 2025 enrollment review but missed this step, it is not too late! Go to Reports, Enrollment in the TELO system and click off the box 2025-2026 Fall Enrollment Review Complete so TE Central knows you have done your work.

If you have not yet completed your fall 2025 enrollment review, please do the following as soon as possible:

- Review all Exports to confirm they remain eligible according to your school's guidelines.
- Review all CONTINUING Imports to confirm their fall enrollment. Update any no longer enrolled to the correct Import status.
- 3. Review and update a I I **NEW** Fall 2025 entering Imports. Update to Enrolled Import status if they are attending your school. If not attending. are update please their Import status to the appropriate status.
- Go to Reports/Enrollment and check the box/enter date to confirm your 2025-2026 Fall Enrollment Review is complete and download your Enrollment Report for your records.
