Updates from TE Central

Don't Forget Those Transfers!

Just a friendly reminder - if your institution accepts transfer student Imports, those applications land in your **Transfer Applications** "bucket" in the TELO system, located underneath your *Imports/Applications*. Be sure to review any new Transfer Import applications you have received!

Did You Complete Your Spring Enrollment Review?

The spring enrollment review confirmation **deadline was January 30th!** If you did not yet complete your TE Spring Enrollment



Review, including checking off the confirmation box on your Enrollment Report, please do so as soon as possible. To reiterate the steps to complete your Spring Enrollment Review are as follows:

1. Review all **Exports** to confirm they remain eligible according to your school's guidelines.
2. Review all **CONTINUING Imports** to confirm their spring 2026 enrollment. Update any students no longer enrolled to the correct Import status.
3. Review and update all **NEW Spring 2026 entering Imports**. Update their record to an Enrolled Import status if they are attending your school. **If they are not attending,**

please update their Import status to the appropriate status.

4. Go to *Reports/Enrollment*, **check box/enter date** to confirm your 2025-2026 Spring Enrollment Review is complete and download your Enrollment Report for your records (Note: If one of your Exports has not yet been Enrolled by their Import school and does not appear on your Enrollment Report, you can still click the box as Enrollment Reports are fluid and do not get locked/frozen).

Call for 26-27 TEGO Nominations!

TE Central is pleased to launch the nomination process for the **2026-2027 Howard D. Saperston Tuition Exchange Grant Opportunity (TEGO) awards!** TEGO provides a **\$2,500 annual award** for up to four years while a student remains enrolled as an undergraduate student - a potential total award of \$10,000 (paid by Tuition Exchange). A maximum of five, new TEGO awards are available for the upcoming 2026-2027 academic year. The TEGO award is an add-on to the TE Scholarship and may be utilized for tuition or non-tuition items associated with the student's cost of attendance. The Import school that offers a TE Scholarship to a TEGO recipient is obligated to provide a scholarship in the amount of full tuition or the TE set rate, whichever is less, and the TEGO award provided by TE would be in addition to that amount. In the event the Import school has an awarding policy that would not support the TEGO terms, the award will be withdrawn.

Export institutions are invited to **nominate two**, new, first-time 2026-2027 TE scholars by submitting the online **TEGO Nomination Form** by **Friday, February 27, 2026**. Export nominations are limited to two per school. The Export student(s) nominated must have an **SAI** (Student Aid Index) from the 2026-2027 FAFSA (Free Application for Federal Student Aid) of **\$25,000 or less**. Encourage families to complete the **2026-2027 FAFSA** at **fafsa.gov** to determine their SAI, or use the **SAI estimator** at **<https://studentaid.gov/aid-estimator/>**. Schools may want to use this **Sample Email** to notify their TE applicants of the TEGO opportunity.

TEGO Timeline:

- **February 27, 2026:** Deadline for TELO to submit TEGO Nomination Form for each nominee
- **March 3, 2026:** TE Central sends student nominees (parent employee/TELO copied) TEGO Application by this date

TELO Tip of the Month

Did You Know...

If you update one of your Import records to reflect an Import status of Leave of Absence, you must be sure to update the student's Import status to "Enrolled" (assuming they do re-enroll the next semester as planned!) within 15 days of the LOA end date you entered, or, the student's record will auto-close out in the system? Currently, the TELO system is set up to allow a student to have one LOA in their TE career; however, TE Central is hoping to change this limit via a future system enhancement over the next few months. Stay tuned!

- **March 30, 2026:** Deadline for TEGO nominee to submit TEGO Application
- **March 31-April 14, 2026:** TEGO Board Committee reviews applications and makes selections
- **April 14-May 4, 2026:** TE Central confirms student SAls and TE scholarship acceptances
- **By May 6, 2026:** TEGO recipients notified
- **By August 1, 2026:** TEGO checks (payable to the school) and enrollment confirmation sent to Financial Aid Offices of TEGO recipients' intended schools.
- **August/September:** TE member school is responsible for confirming recipient's initial enrollment and continuing eligibility each semester
